## RCHCA Covenants

As mentioned in the President's Message, it appears that it may be necessary to take legal action in order to enforce and thus preserve the covenants that protect the quality of life in our community.

From the draft minutes of the last RCHCA meeting, held on October 17, 2016:

*RCHCA Covenants Chair Vince DeCain provided an update on the neighborhood Covenants. Mr. DeCain said the community must be vigilant in monitoring and maintaining the Covenants in order to preserve them and maintain the character of the neighborhood. Recently Mr. DeCain sent a letter to a homeowner, asking them to cease construction of a front-yard fence. The Covenants state: "No line fences or walls of any kind shall be erected except growing hedges or such as may be approved by Rock Creek Hills Covenants, Inc." However, in this case, the homeowners (on Kensington Parkway) did not submit the required neighbor notification and application for construction, which is a violation of the Covenants, and have not responded to Mr. DeCain's letter. Dr. Pekar said that regarding this matter, he saw two goals – one being to enforce and thereby preserve the Covenants, by seeking removal of the noncompliant fence; the other being to ensure that civility is maintained by eschewing and rejecting any discussion of anyone's character or motivations. We seek to enforce and maintain the Covenants, and we will treat everyone with courtesy and respect. A motion was passed for authority to proceed with litigation if this issue can't be resolved amicably.*

After the October meeting, the homeowner who erected the new solid wood fence, including a (partial) front yard fence, without having first submitted the required application for permission, submitted a belated application to construct the fence. In response to this belated application, the Board, keeping in mind that the absence of front yard fences is a positive aesthetic characteristic of the neighborhood; that the absence of front yard fences has been consistently enforced for decades; and that neighbors have expressed alarm over this fence ("There go the covenants?"), declined to approve the front yard portion of the fence, and requested that the homeowner reconfigure the fence. However, the homeowner has not indicated an intention to comply with this request, and so, consistent with the vote of the RCHCA membership at the October 17th meeting, your Board is prepared to take legal action to compel this outcome in order to preserve our

covenants. An update on this matter will be provided at the March meeting.



## Neighborhood Signage

As mentioned in the President's Message, there is an opportunity to erect signage in order to beautify and show pride in our neighborhood. At the June 16,

2016, meeting of the RCHCA, attendees "...passed a motion to form a neighborhood signage committee, which will be in charge of procuring and placing "Rock Creek Hills" signs throughout the neighborhood. Laura Dennis was named the Committee Chair. She will use precedents with the Town of Chevy Chase View and other neighborhoods that have installed signs in the public right-of-way. Potential placement would be on Old Spring/Beach, Kensington Parkway and Saul, Stoneybrook and Kent, and the triangle at Littledale and Haverhill."

An update on this matter will be provided at the March meeting.

## Treasurer's Report and Dues for this Calendar Year

As of publication the RCHCA checking account has a balance of \$1,480.04 and the RCHCA savings account a balance of \$6,096.20. Thus funds for operations are \$7,576.24. All invoices are paid, and due to further contributions, all legal expenses related to school issue were paid without using the general operating funds available last year. Legal expenses related to covenants incurred in the last calendar year have yet to be filed by the attorney.
